**ACCEDE TO THE STANDARD FORM OF THE AGREEMENT FOR THE PROVISION OF SERVICES FOR THE ORGANIZATION OF TRAINING COURSES UNDER THE 'NON-DEGREE' PROGRAM (WITHOUT AWARDING AN ACADEMIC DEGREE), HEREINAFTER REFERRED TO AS THE AGREEMENT, WITH JSC 'MAQSUT NARIKBAYEV KAZGUU UNIVERSITY' (HEREINAFTER REFERRED TO AS THE UNIVERSITY), AND FULLY ASSUME ALL THE RIGHTS AND LIABILITIES AS A REPRESENTATIVE AND A ND STUDENT.**

**I. By signing this 'Application for Accession', a Representative and a ND Student**

- 1) They are fully familiarized and accept the terms of the Agreement published on the University's website on the Internet at: [www.kazguu.kz](http://www.kazguu.kz), and in accordance with the Civil Code of the Republic of Kazakhstan give their irrevocable consent to accede to it;
- 2) In compliance with the regulations of the Republic of Kazakhstan, internal documents and procedures of the University, give their unconditional and irrevocable consent to enrollment in the University's 'non-degree' students (without awarding an academic degree) of the full-time mode of study:

the duration of the 'non-degree' program is:  
1 (One) academic year, subject to the conclusion of an Additional Agreement for the 2nd academic period (semester).  
The total duration of the training courses under the 'non-degree' program upon re-conclusion of the Agreement for the provision of services for the organization of training courses under the 'non-degree' program (without awarding an academic degree) is determined by the Academic Policy of the University.
- 3) Upon signing this Application for Accession, a ND Student undertakes to pay a one-time lump-sum fee, according to the terms of the Agreement published on the University's website, the Payment Regulations for University's Educational Services, and in the amount approved by the Register of the Cost of University Services for the corresponding year of admission.  
This 'Application for Accession' is an integral part of the Agreement.

- 4) They are familiar with and fully accept the terms of the internal regulatory documents of the University, including, but not limited to the University Charter, Academic Policy, Admission Policy of the University, the Register of the Cost of University Services for the 2024-2025 academic year, published on the University's website on the Internet;
- 5) They are duly notified that the payment for the University's services consists of a one-time lump sum payment and payment for educational services.  
\*Note: tuition fees are determined based on the cost of 1 (One) academic credit to the number of credits selected by a ND Student for the corresponding academic period.
- 6) They fully agree that the cost of one credit can be changed upwards, within the inflation rate, but no more than once a year;
- 7) All the information specified in the 'Application for Accession' is reliable and is provided voluntarily and on their own initiative.
- 8) By signing this 'Application for Accession' and Appendix No. 3 to the Agreement, a ND Student and his/her Representative give their unconditional and irrevocable consent to collect, process, store, use, transfer (distribute, provide, give access to state bodies of the Republic of Kazakhstan and organizations, through electronic information systems) and destroy ('Process') biometric data as well as Personal Data related directly or indirectly to a ND Student, which become available under this Agreement and/or when the University provides educational and other services.
- 9) The ND student understands and accepts that he/she is not a full-time student and, in accordance with current legislation, is not entitled to a deferral from military service, and the University does not provide the ND Student with certificates to receive social benefits and payments for presentation to state authorities in the forms established for full-time students.

**II. The Amendments and Additions to the Agreement and the Register of the Cost of University Services for the 2024-2025 academic year are carried out on the terms defined in the Agreement and are subject to mandatory publication on the University's website on the Internet;**

the Ministry of Justice of the Republic of Kazakhstan (MoJ of the Republic of Kazakhstan), which is the owner of the Government Database 'Individual persons' (GD IP), designed for automated collection, storage and processing of information, creation of a National Register of individual identification numbers to introduce a unified identification of individual persons in the Republic of Kazakhstan,

The Ministry of Digital Development, Innovation and Aerospace Industry of the Republic of Kazakhstan (MDDIAI RK), which is the owner of the 'Mobile Citizens Database' service (MCD) - the database of mobile data of citizens of the 'electronic government' of the Republic of Kazakhstan.
