ACCEDE TO THE STANDARD FORM OF THE AGREEMENT FOR THE PROVISION OF PAID EDUCATIONAL SERVICES FOR INDIVIDUALS WHO HAVE NOT SCORED A THRESHOLD POINT ON THE UNIFIED NATIONAL OR COMPREHENSIVE TESTING (FULL-TIME MODE OF STUDY), HEREINAFTER REFERRED TO AS THE AGREEMENT, WITH JSC 'MAQSUT NARIKBAYEV KAZGUU UNIVERSITY' (HEREINAFTER REFERRED TO AS THE UNIVERSITY), AND FULLY ASSUME ALL THE RIGHTS AND LIABILITIES AS A STUDENT.

I. By signing this 'Application for Accession', a Representative and a Student confirm that:

- They are fully familiarized and accept the terms of the Agreement published on the University's website on the Internet at: www.kazguu.kz, and in accordance with the Civil Code of the Republic of Kazakhstan give their irrevocable consent to accede to it;
- 2) In compliance with the regulations of the Republic of Kazakhstan, internal documents and procedures of the University, give their unconditional and irrevocable consent to enrollment in the University's full-time students: by a group of educational programs: (@term2.gop)

academic years, subject to timely registration and development of the number of credits established by the internal regulatory documents of the University, and passing the UNT in accordance with the requirements of the legislation.

The maximum period of study for a separate group of educational programs and the appropriate level of education are determined by the internal regulatory documents of the University.

3) Upon signing this Application for Accession, a Student undertakes to pay a one-time lump-sum fee, according to the terms of the Agreement published on the University's website, the Payment Regulations for University Services, and in the amount approved by the Register of the Cost of University Services for the corresponding year of admission. This 'Application for Accession' is an integral part of the Agreement.

- 4) They are familiar with and fully accept the terms of the internal regulatory documents of the University, including, but not limited to the University Charter, Academic Policy, Admission Policy of the University, the Payment Regulations for Educational and other Services of the University, as well as the Register of the Cost of University Services for the 2024-2025 academic year, published on the University's website on the Internet;
- 5) They are duly notified that the payment for the University's services consists of a one-time lump sum payment and payment for educational services.
 *Note: tuition fees are determined based on the cost of 1 (One) academic credit to the number of credits selected by a Student for the corresponding academic period.
- 6) They fully agree that the cost of one credit can be changed upwards, within the inflation rate, but no more than once a year;
- 7) The student is notified that in accordance with paragraph 2.2.14. of the Agreement, if he/she does not pass the repeated UNT (not getting the appropriate number of points) within the period established by legislation, the Agreement is subject to termination unilaterally, without legal proceedings.
- 8) Pursuant to the terms and conditions of the repeated UNT, this Application for Accession and the Agreement are not subject to renewal. A Student is subject to enrollment in the main membership of students.
- 9) All the information specified in the 'Application for Accession' is reliable and is provided voluntarily and on their own initiative.
- 10) By signing this 'Application for Accession' and Appendix No. 3 to the Agreement, a Student and his/her Representative give their unconditional and irrevocable consent to collect, process, store, use, transfer (distribute, provide, give access to state bodies of the Republic of Kazakhstan and organizations, through electronic information systems) and destroy ('Process') biometric data as well as Personal Data related directly or indirectly to a Student, which become available under this Agreement and/or when the University provides educational and other services.

IV)IV The Agreement comes into force from the moment of signing this Application, under the following conditions:

- 1) deposit by a Student or his/her Representative to the payment account of the University:
- a one-time lump-sum entrance fee no later than 10 (Ten) banking days from the date of signing this Application for Accession:
- the full amount of the cost of the selected academic credits no later than August 25 of the current year.
- *Note: the amount of a one-time lump-sum payment and the cost of one academic credit are set in the Register of the Cost of Educational Services approved by the Executive Body the Board for the corresponding year of admission and by the Payment Regulations for educational and other services of the University.
- 2) providing a complete list of documents defined by the University's Admission Policy to the Admission Office.

V) The Agreement may be terminated by

by the Student by:

- submitting an application (in writing) for expulsion, subject to the conditions provided for in the Agreement for the provision of paid educational services;
- the issuance of an appropriate expulsion order.
- *Note: obligations to pay for educational (for the relevant academic period, in accordance with the registration conducted by the Student) and other services of the University remain until the complete fulfillment by the Student and/or his/her legal Representative.

Upon termination of the Agreement for the provision of paid services, before the applicant is included in the Student enrollment order, part of the one-time lump-sum fee will be refunded, under the procedure and conditions determined by the Agreement for the provision of paid services as well as the Payment Regulations for Educational and other Services of the University.

The Parties have agreed that upon the occurrence of the circumstances specified in this section of the Application for Accession, the conclusion of the 'Arrangement on Termination of the Agreement' is not required.
